Approval of Minutes from previous meeting

The minutes from the previous committee meeting were read and approved as accurate.

Health and Safety

- Ongoing: The club's insurance policy has several endorsements regarding the kitchen operation which the club must meet including fire extinguisher requirements, extraction hoods, deep and shallow fryers and handling of deep-fried food scraps.
- Ongoing Brett Avery is looking at a possible upgrade to the slipway winch drive system
 to improve its safety. He will also check the winch's securing bolts as they are subject to
 saltwater immersion during spring high tides.
 Update: No new winch for now. Barry to follow-up regarding a sheetmetal guard over
 the drive system. The winch attachment bolts are also heavily corroded so need
 replacing. The current idea is to build a pedestal below the existing winch that both
 replaces the attachment bolts and raises the winch above the high tide water level.

Financial Report

- The July financial accounts were presented by Trish.
- Month-end result was a small loss of \$0.3k against a budgeted loss of \$3.3k.

- Membership renewal invoices were sent out at the end of July. Income from renewals exceeded budget by \$7k.
- The club will have sufficient funds to cover expected August invoices. To ensure we have cash on hand to cover unexpected costs during the next few months the committee agreed not to roll over one of the Term Deposit. Instead, the funds will be placed in a monthly interest account.
- Trish is attempting to resolve an issue with two of the club's mooring renters regarding outstanding fees. The renters will be given one more month and if the issue is still not resolved they will be asked to remove their boat from the mooring.
- Ongoing Reviewing the Bar KPI tracking graphs, it is clear we are spending too much on beverages with respect to sales.
 Update – Bruce carried out a stock take of the Phathouse beer and wastage appears to be well within the guidelines of 2%. An urgent stocktake of all other beverages will be carried out this week.
- Bank Account balances are available to Club Members on request.

- Ongoing Annie is working on an event program that will be available for sale.
- Ongoing Would be helpful to have a new rum sponsor. Suggested we approach Mount Gay.
- Ongoing Still looking for someone to coordinate proceedings for the week leading up to the event and on the day.

- Ongoing: Ian will email all contestants of this year's regatta when the new poster is available thanking them for supporting the club by participating in the regatta and inviting them to attend next years 50th anniversary event.
 - Update Ian will work with Mark to use Mailchimp for this email.

Youth Sailing - Mark Thomson

- The committee were happy with Jay's proposed Youth Sailing program for the summer period. As well as running his normal after school and Christmas period programs he's also hoping to run YNZ's Runa program for both Russell and Waikare Schools. Russell School is hoping to send around 45 children aged between 8-12 years and Waikare School will send approximately 22 children aged between 11-16 years. Both schools have a preference for the program to run during the 4th term of this year.
- Jay is also hoping to run an Adult learn-to-sail program during early September where participants would be expected to make a donation of \$150 towards the summer youth sailing program.
- The committee discussed and agreed on a renewal frequency of 5 years for Police vetting of coaches and assistance coaches involved in the Youth Sailing program.
- Ongoing Jay has requested that the club purchase a replacement RIB. The model he has selected is a Southern Pacific Shearwater 340 listed at \$5,295 with free delivery.  Christine Mosses has offered to assist with the fundraising for this purchase.

Slipway, Dinghy Dock & Moorings – Barry Newland & Paul Thompson

- It was suggested that we request via mainsheet for a small group of volunteers to assist with the jetty pile replacement and slipway winch remounting projects. This might be a better option rather than trying to complete these tasks during a normal working bee.
- Ongoing Jetty security is an ongoing issue. One option the committee will investigate is improved lighting in the form of a solar powered sensor activated LED flood light mounted on the outer pontoon.

Update – The new light has been installed, thanks to Fletcher and Geof. A second light might be needed to ensure the full jetty is sufficiently lit.
