Approval of Minutes from previous meeting

The minutes from the previous committee meeting were read and approved as accurate.

Health and Safety

- Ongoing: The club's insurance policy has several endorsements regarding the kitchen operation which the club must meet including fire extinguisher requirements, extraction hoods, deep and shallow fryers and handling of deep-fried food scraps.
- Ongoing Brett Avery is looking at a possible upgrade to the slipway winch drive system to improve its safety. He will also check the winch's securing bolts as they are subject to saltwater immersion during spring high tides.
 Update: No new winch for now. Barry to follow-up regarding a sheetmetal guard over the drive system. The winch attachment bolts are also heavily corroded so need replacing. The current idea is to build a pedestal below the existing winch that both replaces the attachment bolts and raises the winch above the high tide water level.

Financial Report

- The June financial accounts were presented by Trish.
- Month-end result was a loss of \$6.1k against a budgeted loss of \$6.0k.

- Cash Flow we are short \$10k in the current account to pay the invoices due on the 20th of July. A transfer of another \$5k from the building fund will go some way to help.
- The first insurance instalment of \$1,800 is due on the 1st of next month.
- The are two significant outstanding slipway invoices. It was suggested by several committee members that the club should move to a "pay before you splash" model which is in line with the way most marinas operate.

- Reviewing the Bar KPI tracking graphs, it is clear we are spending too much on beverages with respect to sales. Trish to have a closer look at beer sales vs purchases to determine the level of wastage. Stephen suggested a good target for wastage is 2%.
 Bruce suggested there could be an issue with the chilling of the taps. Stephen to call PhatHouse to see if they will supply some new Taps.
- Ongoing: Club house hireage continues to provide a financial benefit to the club.
 Stephen to look at putting a flyer together to help with promoting the club house as a venue.
- Ongoing: We need to check the long-term power usage of the club's refrigeration units.
 With Joel moving out of the area we will now approach Smith Electrics to see if they can assist with this task.
