

# COMMITTEE MEETING 9 July 2018

## **MINUTES**

### Meeting Commenced at 1905 hrs.

**Present:** Jay Howell, Barry Newland, David Scoffham, Robert Adams, Tui Allen, Christine van Beurden, Trish van der Sande (bookkeeper)
Minutes taken by Jay Howell

- 1. Approval of Minutes
  - a. The Draft Minutes of the General Committee meeting dated 11 June 2018 were approved.
  - b. The Draft Minutes of the Special Committee meeting dated 9 July 2018 were approved.
- 2. Health and Safety no health and safety matters were noted.
- 3. Financial Report
  - a. Audited Financial Statements final draft copy circulated to committee members for consideration and approval. After brief discussion the committee unanimously approved the draft audited financial statements. These will be distributed to members in a newsletter once finalized.
  - b. Profit/loss for May (separate document). Key items to note include:
    - i. \$10.4k loss for month
    - ii. Bar and kitchen sales comparable to last year
    - iii. Bar and kitchen profits down due to higher costs
    - c. Loss includes annual insurance premium of \$5.7k, NRC slipway penalty of \$1k and \$1.5k wine restocking cost.
    - d. Loss includes NRC slipway penalty
  - e. Bank balances 31 May (separate document)
    - i. Cash down \$13k due to \$10.4k loss noted above and \$2.7k net GST payments
  - f. Payments to approve circulated to committee members
  - g. A brief follow-up discussion of the Club insurance policy was held, noting plans to more proactively explore options next year.
  - h. Banking status paperwork is in process to add Christine van Beurden as a signatory to our bank accounts.

The financial report and payments to approve were unanimously approved.

4. The committee further discussed the membership renewal process and draft renewal notice and invoices that are planned for distribution to members in August. The Commodore will prepare and send the renewal notices and the Secretary will maintain the membership records in conjunction with the bookkeeper.

#### 5. Club Hire Applications

- a. 6 October Harry Lyon album release party the committee agreed that this event should be a Club sponsored event as opposed to a private club hire and approved the event in concept. Particulars still need to be planned.
- b. 13 October 80<sup>th</sup> Birthday party club hire more information is needed before proceeding.

  - i. Sewage Pump was replaced at an approximate cost of \$1100 plus installation. We will also undertake to install an overload switch to protect the pump from future failure. The holding tank has been cleaned out, and the Club should obtain maintenance clean-outs annually in the future.
  - ii. Light switch repair Trish & Brent to follow up with this item
  - iii. Ladies toilet light needs replacing Trish & Brent to follow up with this item
  - iv. It was reported that a new draft has been identified that might be better sealed.
  - v. An update on planning for lifting clubhouse was provided, including a recap of the recent meetings held to obtain member and community input. The building committee will be meeting with a building engineer on Tuesday to discuss technical considerations.

- i. Trolley status the Club should receive a quote for a replacement trolley later this week.
- ii. It was reported that the Club is receiving a donation of pontoons that are suitable for use adjacent to slipway.
- iii. NRC consent compliance and penalty assessment these amounts were paid last month, and it is expected that the Club will receive reimbursement from a member for \$750 of the cost.
